# **Rules and Regulations:**

- All participants are to obey any and all rules, signs, markings, flags etc. set up by the Kyalami marshals and VWCSA committee and any and all track Officials at all times during the event and around the race track at all times.
- All participants are to adhere to the required speed limit with in the pit lane and "off the track" as set by the VWCSA Committee at all times during the event and throughout the day of the event.
- Any dangerous or reckless driving, whether it endangers other track users or not is strictly prohibited at all times and any transgressors will be dealt with in the appropriate manner.
- All vehicles used in the event are to be in a roadworthy condition and any vehicles that are suspected of not being in a roadworthy condition may be restricted from participating in the event.
- Drivers of participating vehicles are responsible for the comfort, safety and behavior of their passengers and need to ensure that they abide by the rules and regulations of the event at all times. All passengers have to sign an indemnity before entering the track.
- Respect and courtesy will be given to all slower track users by all participants at all times.
- A committee vehicle will have basic mechanical spares and a first aid kit but for use in the unlikely event of a breakdown or medical emergency.
- Video and still camera footage will be taken throughout the event and this will be coordinated by the clubs official photographers.
- Participants are more than welcome to take their own video and still camera footage, provided it does not interfere with the running of the event, break rules or regulations or interfere with other track users.

### Indemnity:

The Participant agrees to indemnify, hold harmless The Volkswagen Club of South Africa, Kyalami and its officers, sponsors and representatives from and against the following damages, losses and liabilities arising from or as a result of the negligence or fault of the Participant:

- Any Liability with regard to claims by governmental authorities or others for non-compliance by the Participant with any Act of Parliament, law, ordinance, regulation or by-law made by a lawful authority.
